Champs Provide Variety of Options for Swimmers

Colonies Zone offers 5 zone championships each year. Following is a progress report since the 1999 convention meeting.

SCM Champs

Two-hundred-eighty-seven swimmers descended on Rutgers University for the November 6-7 1999 Colonies Zone SCM Championship. They represented 22 separate teams. The meet offered 28 events. Thirteen individual national records were set, 5 of them also world records. These records are good as of the November 1, 1999 published listings. There were also 111 women's zone meet records, 96 men's zone meet records set, 5 female relay zone records, 10 male relay zone records, and 9 mixed relay zone records set.

The following swimmers set individual records (world records are marked with asterisks):

The creation of this ad-hoc committee by President Nancy Ridout gave official stature to the project initiated by Carl House several years ago. The initial website listing current top tens was expanded to include current All American and All Star listings.

Warning About Online Registration Offers

Hugh Moore, Zone Chair, passed this information on to the Zone Reps recently. Any meet directors out there should be aware of companies offering on-line registrations. Hugh said:

"Over the past year a number of companies have approached meet directors of various events offering to either list their events in their calendars or to provide on-line registration. At least one of the vendors uses some hard sell tactics and makes some false claims. USMS is not currently negotiating any arrangements for on-line registration or for calendar listings. Also, an electronic checkmark is NOT the legal equivalent of a signature. Let me know if you have any questions."

only vote on the concepts and create some grounds for discussion at our convention meeting.

Finances

At the convention in September, we voted to change the basis of zone funding from \$50 per LMSC to 15¢ per registered swimmer. With 1999 registrations at 7426 swimmers, we will have \$1,113.90 in income with about \$348 left at the end of the year.

The Zone Financial Statement on page 2 shows what each LMSC will owe. Registered swimmers are in parentheses following the LMSC name. If any LMSC has a different number, please notify me. Formal bills will be distributed at the zone meet-

ing on April 1 to be paid by June 1.

At our convention meeting next October, we will revisit the issue of the amount of the fee and determine if it should stay the same or be changed.

Web Site

In case you haven't visited the Colonies Web Site recently, the site has been given a facelift. It is now a frames site which allows us to be more creative and flexible with our navigation and updating.

You get to the web site in the usual way by going to colonieszone.org. URLs which point to PDF files or any files which should be viewed alone (such as meet results or records) are opened in their own windows. Use the "Back" arrow on your browser to get back to the regular frames view.

Any page on the site can also be viewed without the frames format. If you don't have a frames-capable browser or just don't like frames, go directly to the home page at colonieszone.org/home.htm or the sitemap at colonieszone.org/sitemap.htm for navigation.

If you arrived at our web site through a link from another site, you can get to the frames version by clicking on the "Frames Version" link in the footer.

For those of you who are members of "Stats Anonymous," as of March 16, we have had 1815 visitors with an average of 9 visits per day. The biggest bump occurred last fall when the heat sheets and results for our SCM championships were posted. If you want to look at other stats, click on the world with the wire around it at the bottom right of the home page.

LMSC Health

At the end of 1999, we had mixed results on LMSC membership. Overall, the zone increased registration by 314 swimmers. However, only 5 of our LMSCs grew, while 5 lost membership. Numbers don't always indicate the health of an organization, but it is something we have to be aware of. I don't know if these losses or gains are a continuation of a trend or just an aberration.

Summary of Zone Meeting September 18, San Diego, CA

The Annual Meeting of the Colonies Zone was held at the USMS National Convention on September 18, San Diego, CA. Forty-two members of the zone attended the meeting.

The Zone Rep read into the record a list of achievements for zone members in 1999. They were: 1) 1999 Ransom Arthur Award—Jim Miller; 2) ISHOF Induction—Kelley Lemmon; 3) USMS Service Award Winners—Bob Kolonkowski, Jim Matysek, Lynn Hazlewood, Ed Nessel, and Art Mayer; 4) 2000 Rule Book Cover—Design by Tom Lyndon; 5) 2001 Long Distance 1-Mile National Championship—Empire State Masters; and 6) 1999 USMS National Championship Award—Jim Matysek.

Five zone championships were awarded at the meeting. This included the first ever zone open water championships. The awarded meets are: 1) 2000 SCY—3/31, 4/1–2, Rutgers University, Piscataway, NJ, Rutgers Masters; 2) 2000 Area 1 Open Water—6/24, 3-Mile, John's Pond, Mashpee, MA, Mashpee Leisure Services; 3) 2000 Area 2 Open Water—7/15, 1-Mile, Atlantic Ocean, New York,

NY, Empire State Masters; 4) 2000 Area 3 Open Water—5/28, 2-Mile, Lake Audubon, Reston, VA, Reston Masters; 5) 2001 SCY—4/20–22, Nassau County Aquatics Center, New York, NY, Empire State Masters. The 2000 and 2001 SCM championships and the 2001 open water championships are still available for bids.

Among the other actions accomplished at the meeting were: 1) Approval of setting up and funding a web site with the domain name of colonieszone.org; 2) Approval of on-deck coaching at pool championships and the purchase of t-shirts for the coaches; 3) Approval of a budget for 2000 which is funded by a 15¢ per registered swimmer charge and eliminate the current \$50 per LMSC charge for zone funding; 4) Reelection of Zone Rep for another 2-year term; and 5) Setting of the date for the next zone meeting at the SCY Zone Championships on Saturday, April 1, 2000 at the conclusion of events for the day

Garden State Masters won the large team competition (20 swimmers or more) with 2230 points. They were followed by Colonials 1776 with 1717 points and Empire State Masters with 1279. Maryland Masters won the small team competition (19 swimmers or less) with 955 points with Connecticut Masters 2nd (615 points) and White Plains Masters 3rd (587 points).

Gus Langner, 96, CONN and Roger Franks, 72, C1776 won the men's high point award. Each had 10 first places for 90 points. Marcia Hill, 55, EMP and Lida Gaschke, EMP tied for first place in the women's high point award. Each had 9 first

places and 1 second place for 88 points.

The 2000 SCM Championship is open for bids to anyone who wants to bid.

SCY Champs

OW Champs

The first Colonies Zone Open Water Championship will be held on May 28 in Lake Audubon, Reston, VA and is sponsored by Reston Masters. It is a 2-mile swim around a 1/2-mile rope course. In 1997, this swim was the 1–3 mile national championship. A description of the event with pictures, a PDF version of the entry form, and a list of current entries can be found on our web site at colonieszone.org/comp/reston2mi.htm.

The next championship is on June 24 and is a 3-mile swim in John's Pond, Mashpee (Cape Cod), MA. The swim is also the USMS 3–6 Mile Long Distance National Championship. It is sponsored by Mashpee Leisure Services. Contact Gus Frederick at 508-539-1447 or leisure@cape.com for entry information.

The final championship on July 15 is a 1-mile swim at Point Lookout, Long Island, NY sponsored by Empire State Masters. This is also the New York State Championship and in 2001 will be a USMS 1 Mile Long Distance Championship. Contact Bob Kolonkowski (see zone address list on page 11) for information.

Information on the June 24 and July 15 championships will be posted on the Colonies Zone web site as soon as available. There will be another zone newsletter out in early May with the entry forms.
