Zone & Nat'l Issues Provide Convention Topics

Management Committee May Bring Resolution to House of Delegates

As convention draws closer, we are also getting closer to making some decisions on the future direction of United States Masters Swimming. A resolution will be debated on Wednesday at the 4:30 PM Board of Directors/Professional Management Committee meeting. The committee may decide to present it to the convention, with or without amendments, or defeat the proposal.

Review of Initial Work

This is the second in a series of articles describing the activities of the Ad Hoc Professional Management Committee. The committee is comprised of the USMS Board of Directors and members with special assignments. The purpose of the committee is to review the current USMS tasks and administrative structure and to make recommendations for change or nonchange in the way we do business. The first article appeared in the summer 1998 *Colonies Zone News* and discussed the initial stages of the committee's work.

Step one was to survey other organizations concerning their management structure. The results of this survey showed that USMS is a unique organization in that it is largely run by volunteers. Most similar or-

Work Groups Form Basis for Discussion At Saturday Morning Convention Meeting

One of the things I have noticed over the years is that, during our Zone meetings, we seem to get "stuck" on a particular topic to the exclusion of others. This year, I would like to borrow the work group concept from the larger convention in order to make our discussions more productive and to take advantage of the extra hour we have to meet.

After I finish my administrative report, we will break into work groups for 30–45 minutes to discuss issues. Following this

period, the work groups will report to the meeting. I would like the groups to have specific recommendations for the whole group to discuss and vote on. In addition, they need to give thought to implementation of their ideas. This should include a time frame, financial considerations, and personnel assignments. It may be that we won't get to everything in this one meeting, but it will be a start so we can accomplish more throughout the year.

I have set up four specific work groups plus an optional group called "Miscellaneous." This last group will cover any topics not being considered by the named groups. One topic that you may want to discuss, is the Zone Coach/Mentor program we touched on briefly last convention. There seemed to be some interest in doing this. If you have anything you would like to promote as a zone activity, volunteer for this discussion. Please be prepared to go into the work group of your choice when the time comes. It would be helpful if you gave some thought ahead of time to what your opinions are. The following proposed agendas for the groups are only meant to stimulate discussion, not circumscribe it.

Zone Champs Work Group

Five or six years ago, the people at the zone meeting decided that we wanted to consistently have a SCY Zone Championship each year and make it an important meet. I think we have succeeded admirably. We now have a meet each year and it is well attended. It's time we started thinking about expanding our zone championship opportunities. After all, this is the way we can benefit more competitive swimmers in the zone. In your discussion, please consider the following:

1) Committment to events—Whatever we

do about zone championships, we need to make a committment to the events we set up as we did to the SCY championships. Just saying we'd like to have a championship won't get it done.

- 2) Allow for limited meets—With the exception of the SCY Championships, which I believe should continue to be a fully implemented 2–3 day meet, allow hosts to offer one-day championships.
- North-South concept—Consider having a northern zone championship and a southern zone championship.
- LCM Postal Championship—See Tracy Grilli's article on page 3 column 1. This is an idea we approved last year.
- 5) Open Water Championships—We have many open water events in the zone. If we were to offer open water championships, we need to define how many will be offered and what distance specifications there will be, if any. You might want to consider offering a special participation award for anyone who swims in all the open water zone championships in one season.
- 6) Postal Championships—Running a postal championship in the traditional sense could offer competition to zone swimmers without the necessity of renting a facility, travel, etc. It would also provide experience in running a postal event for hosts who wish to bid for a National Championship.
- 7) Promote LMSC & Zone Competition— We could set up some kind of competition between LMSC's and with other zones (as we did in 1997 with Dixie Zone) in conjunction with our championships.
- 8) Zone Championship Medals—Producing our own Zone Championship medals will give us economy of scale, reduce costs and logistics for meet hosts, and create a special award to go with the championships. We would need volunteers to design, purchase, and administer the medals program. In addition, seed money would have to be found for the initial production before meet hosts begin to pay us for what they use.
- 9) Bidding process—How do we encourage more hosts to bid for champion-

ships? In addition, if we add more championships, we will have to make the bidding process less ad hoc.

Awards and Recognitions Work Group

I think we could do a lot for the swimmers in the zone if we established some records and goals for them. There are a lot of swimmers who may not be able to achieve on the national level, but can do so on the zone level. This work group will be identifying those areas where we could maintain information and some sort of recognition for those who achieve. Please remember that this should include open water events, where appropriate, as well as pool meets. Possible areas are:

- 1) Zone records.
- 2) Zone championship records—I believe we already have these for SCY.
- 3) Zone top ten—current year as well as all time.
- 4) Zone all stars—qualifications for all stars would have to be set.
- 5) Swimmers of the year for each course based on achievement such as top ten, most first places in meets, etc.

In addition to recognizing competitive achievements, we should establish service awards for members who work on the administrative side for their LMSC or the Zone. The work group needs to identify the award categories and methods for nominating and approving the winners.

Publications Work Group

Currently the only publication the zone has is the zone newsletter. Traditionally, this has been the province of the Zone Rep as a vehicle for communicating with the zone leadership. I think this is a good use for the newsletter and I am willing to continue publishing it. I would like to have regular correspondents from each LMSC . When you come to convention, please be prepared to identify your correspondent. Each LMSC may choose what information to put in the newsletter. The deadline for the December news is November 15.

The major job of this work group is to discuss the possibility of starting a zone web site. Some areas for discussion can be:

1) Webmaster—Identify who will be the webmaster and which members will

- work on the web site with the webmaster.
- Web Site—Identify possibilities for the location of the web site and how many MB's are needed.
- 3) Contents—Begin to build a list of items to be placed on the web site. Consider what will be unique to the zone and not a repetition of existing masters sites. Among possible items are:
 - a) Reports from the Zone Rep.
 - b) Copy of the zone newsletter and excerpts from LMSC newsletters.
 - c) Profiles of zone leaders.
 - d) Work groups progress reports.
 - e) Bulletin board.
 - f) Information on zone championships. This would include which are available, how to bid for one, list of the year's championships, entry forms or links to them, results or links to results, etc.
 - g) Links to other masters web sites.
 - h) Pages for zone records, top ten, awards, etc. These items will depend on the productivity of the Awards & Recognitions work group.

Finance Work Group

The finance work group's job will depend on the spending requirements presented by the other work groups. Currently our finances are only used to provide funding for the Zone Rep at convention. Some time ago, we decided that each LMSC would contribute \$50 per year. This was considered fair because the Rep worked for the entire zone and smaller LMSC's would have difficulty funding an extra person.

As the other work groups report on their ideas, the finance group should be prepared to identify possible sources of funding. It would be helpful if some experienced fund raisers were in this work group so they can identify which methods, in their experience, are most productive. Some areas to explore are:

- 1) Sponsors to provide goods and services.
- 2) Fund-raising events.
- 3) Small fee per registered swimmer.
- 4) Fixed fee per LMSC as we do now.
- 5) Advertisements in publications.
- Fee per swimmer entered in zone championships.

Zone Rep Seeking Documents To Complete Zone Archives

I would like to create Zone Archives which contain all the documentation of Zone activities for as many years as we can find. Currently I have nothing other than a few things that I have collected over the past couple of years. I can use either hard copy or electronic versions.

Colonies Zone LCM Postal Champs Status Report

The idea of a Zone Long Course Postal Championship meet "was hatched" at last year's Colonies Zone meeting at the USAS Convention in Burlingame, CA. For a number of reasons, there were no "takers" to host this event and I came up with the idea of making it a postal meet.

The basic idea for this meet was that the LMSCs would run their local meets. Upon completion of all the LMSC meets, results would be submitted to a postal meet director, then tabulated. Results would rank all swimmers participating by age group and event.

I started with a basic outline of how I thought it could work then sent this to the representatives from each LMSC who expressed interest in working on this project. As correspondence continued back and forth, we ended up with more questions and concerns and not enough time to pull this off.

What I realized through this process is that this is a huge undertaking and it needs to have the support of all the LMSCs. If we have the support, we then need representation from each LMSC in forming a meet committee. Once formed, we will work together in figuring out how to make this work and be successful. At this time, we are still in the brainstorming stage.

Again, this is a huge undertaking. The question is, does our membership want this? We will discuss this further at convention—See you there!

ganizations, even those with smaller memberships, are run by a professional staff. The second step in the process was to survey the committee members concerning their opinions about tasks USMS is doing now. They were to evaluate each task and specify whether it should be done by paid professional staff and when that transition should take place.

Survey Results

Results of the survey are presented on page 5 of this newsletter. Briefly, thirty-three of thirty-eight respondents believed we should work toward expanding paid professional positions. The other five said we should never expand. The majority feel that we should do this within the next six years although, if you look at the individual scores for the various tasks, many fall into the 6–10 year implementation category. It is interesting to note that according to the survey, the order of tasks to be converted proceed from administrative jobs, to detail work, to more substantive tasks, and finally

to tasks involving LMSC and club activities.

Convention Resolution

The resolution which will be discussed at convention is on this page. It proposes that we expand the national office to include an Executive Director plus employees necessary to complete the tasks assigned. The office will be expanded by January 1, 2000 with an annual budget not to exceed \$200,000. The Executive Director will be in charge of the operations of the national office and will serve the USMS Executive Committee.

Initial tasks assigned to the office will be those of the National Executive Secretary, National Registrar, and Controller. In addition, the office will perform tasks assigned to it by the Executive Committee, handle solicitation and support of national sponsors, and provide assistance to national committees, the Executive Committee, and the LMSCs.

Committee Discussions

Since the beginning of September, the

Professional Management Resolution

The USMS House of Delegates authorizes the USMS Executive Committee to expand the current USMS national office by January 1, 2000.

The office shall be headed by an Executive Director who shall hire the necessary employees to complete the tasks assigned to the office.

The Executive Director shall be hired by and report to the Executive Committee and shall not be allowed to make USMS policy. The Executive Director, with concurrence of the Executive Committee, shall hire and oversee all employees and contractors. The Executive Director shall be in charge of the operation of the national office.

The initial annual budget for the combined office shall be no greater than \$200,000.

The national office will perform the tasks currently performed by the National Executive Secretary, National Registrar, and Controller.

Additionally, the office will provide improved services to USMS members and LMSCs by:

- ~ Soliciting and providing liaison support to national sponsors
- ~ Providing assistance to national committees as requested by committee chair or Executive Committee
- ~ Providing assistance to LMSCs as requested by LMSC chair or Executive Committee
- ~ Performing tasks assigned by the USMS Executive Committee

committee members have been corresponding by e-mail concerning the resolution and the philosophical issues behind it. This has been a lively and interesting debate. Much of the discussion has centered on three separate issues: 1) When should we make a decision about expanding the national office; 2) What will be the nature of the Executive Director position; and 3) What is the mission of United States Masters Swimming. These questions are intertwined and no decision will be complete without answering all of them. This will probably not happen until we get to convention and actually get to work.

When to Decide

A lot of commentators have expressed concern about having enough time to make a decision at this convention. This may be because most of the work this year has involved gathering data with very little discussion about the substance of the issue until recently. There is some support for a longer session, possibly with a facilitator, to cover all the issues involved. This could be done next year in San Diego prior to the official start of the convention.

As some contributors pointed out, however, a longer session next year presents two problems. First, will enough interested committee members be able to attend? Second, what will putting off a decision for one year mean to the implementation time frame? USMS President Nancy Ridout points out that it wouldn't be fair to saddle the next Executive Committee with the job of handling this transition. If we make the decision this year and hire staff by the beginning of the year 2000, the current Executive Committee can oversee the process.

Executive Director

A large amount of ink was devoted to the kind of Executive Director to hire. It seems that most of the commentators want to make sure we don't end up with an executive director who will follow their own agenda and not go where our leadership desires. Some would solve the problem by hiring a policy coordinator who is essentially a business manager. Others feel that we need a real leader who can help run the

USMS and move us into the future under the direction of the Executive Committee. The solution to this problem lies with the effectiveness of the Executive Committee. A strong leadership will maintain control of USMS regardless of the nature of the executive director. As Nancy puts it, "WE provide the leadership; WE define the focus and the mission of USMS. Any staff we hire will carry out the responsibilities we give to them."

Our Mission

Much of the agony over when to do this and how strong an executive we need seems to come from a lack of clarity about the mission of USMS as we go into the future. Some of the commentators seem to be saying that we can't make this decision until we define ourselves. Hence the desire for a longer meeting next year. Some say we make the decision and then define ourselves. Interestingly, except for Nancy, none addressed the issue of what that mission should be.

She said "In my mind, our mission extends beyond providing fun, fitness, and competition for our members. I see our program as a vehicle for adult fitness in America." This is an intriguing idea and one which dramatically expands the horizons of USMS. In order to effectively meet this goal, masters will have to become a force to be reckoned with.

It will require an organization and an effort beyond what is possible for volunteers to do, no matter how talented and motivated. This includes competing for funding dollars so swimmers have the op-

Survey on USMS Tasks

Of the 38 members who responded to the survey, 33 said we should expand paid positions as follows:

- 19—expand in the next 2 years
- 12—expand in the next 5–6 years
- 1—expand in 10 years
- 1—expand in 20 years

portunity to train to a level of true fitness. It also means an investment in education so the ordinary swimmer understands the value of real training, whether they intend to compete or not.

To really be a "vehicle for adult fitness in America" we have to do something about the deficiencies on the local level. No matter how good our national organization is, if you can't get water time and quality coaching, you won't be able to provide real fitness opportunities for the average swimmer.

I can go to my health club and choose to do weight training, yoga, karate, aerobics, spinning, etc. all with trained and certified instructors. In 24 years as a masters swimmer, I have never been able to do that

with my swimming team except for three and one-half months this summer when my team had the privilege of training with an outstanding age group coach who happened to be between jobs.

Rutgers to Host SCM Zone Championship

Rutgers Masters Swim Club has once again offered to run the Colonies Zone SCM Championship. The meet will be October 10–11 at the Sonny Werblin Recreation Center at Rutgers University in Piscataway, NJ.
