SCY Championships Attract 514 Swimmers to New U of MD Natatorium

The first ever Colonies Zone SCY Championship held in Potomac Valley was hosted by the Terrapin Masters on April 30th, May 1st and 2nd, at the new University of Maryland College Park Pool.

With 514 entries from as far away as Michigan, Alabama, Illinois, and even Russia and the Ukraine, the competition was intense and exciting.

The largest team was from the Colonials 1776 club with the Maryland Masters close behind. In addition, we had strong contingents from Virginia Masters, DC Masters, Garden State Masters, Empire Masters and the Ancient Mariners.

Two simultaneous short course yard pools were used with odd heats in one and even heats in the other. This arrangement had been successfully used at the Indianapolis Natatorium as well as the Hall of fame pool in Fort Lauderdale.

The meet drew great reviews not only for the facility but also for the running of the meet itself. The pool proved to be very fast with over 100 zone meet records broken as well as six national records over the three days.

The Colonials 1776 club won the high

Finances Top the Agenda at Colonies Convention Meeting

Other Important Topics Include Web Site and OW Championships

Following the zone rep's report on the state of the zone, we will entertain bids for zone championships. All the events listed on the bid form on page 9 are open for bids. At a minimum, we need to make sure we have the full complement of championships assigned for 2000.

After the bids, we will break up into work groups for more intense discussions. The work groups will report to the floor and any resolutions will be voted on. With the remaining time, we will take business from the floor, discuss convention hot topics, and finish up with the zone rep election.

Finance Work Group

In the past year, the zone has identified or implemented several projects that will need funding. The Finance Work Group needs to come up with some ideas for raising revenues for the zone or we won't be able to proceed. In addition, we need to determine if the new fund raising would replace or augment our present method of collecting \$50 per LMSC.

Currently, the only funding the zone does is \$500 for convention expenses for the zone rep. The other projects that may need funding are: 1) T-shirts for on-deck coaches; 2) Open water championships awards; and 3) Web site costs. The work groups responsible for these projects will need to determine whether they want to go forward with the projects and how much money they will need.

T-shirts for on-deck coaches are \$12 per shirt. We used five shirts for the SCY Zones last spring and have three remaining for future meets. If we limit the shirts needed to 5 per meet, we may have to buy 5–10 per year, depending on how many coaches return and have their own shirts.

Last spring we voted to sponsor open water championships (see resolution on page 3) and produce championship medals as well as awards for overall champions. If this plan goes forward as specified, we will need seed money to pay for the initial order of medals as well as money for the champions awards. Each meet will probably need 50–60 awards for individuals and teams, depending on their entries.

The web site is currently housed on the Virginia Masters web site. If we choose to have our own web site, there will be expenses of \$25–\$50 per month plus set-up fees, depending on the plan chosen. In addition, use of our own domain name, if we choose, would require set-up costs.

Jim Miller Wins Ransom Arthur & Kelley Lemmon Inducted at ISHOF

As most of you know, two more Colonies members have been decorated this year. Jim Miller, from Virginia Masters, has been named the winner of the 1999 Ransom Arthur Award—the highest honor in masters swimming. Kelley Lemmon, 87, from DC Masters was one of two masters swimmers inducted into the International Swimming Hall of Fame in Fort Lauderdale.

Jim Miller is the chair of the USMS Sports Medicine Committee, coach of the Virginia Masters Swim Team, and served as USMS Vice President from 1993–1997. He is also a Fellow of the American Academy of Family Physicians with a subspecialty in Sports Medicine. Jim has been certified as one of eight team physicians for USA Swimming's international team for the next Quadrennium.

Kelley Lemmon learned to swim early and was on the swim team at the U.S. Military Academy, graduating in 1937. After a distinguished military career, he retired in the early 1970s. In 1979, he began lifting weights and returned to swimming as a masters swimmer. He has held 128 world records, 49 national records, and 65 USMS National Championships. Some of his records still stand. While shoulder problems ended his competitive career, he still swims recreationally and has not ruled out a comeback.

"The Shootout II" Bumped by USMS 2000 SCY Nationals

I regret to announce that "The Shootout II" with the Dixie Zone scheduled for April 21–23, 2000 may have to be postponed. Phoenix Swim Club has officially pulled out of the 2000 Short Course Nationals and the meet has been rescheduled for April 27–30, 2000 at the IUPUI Natatorium. It is not feasable to expect swimmers to travel to Fort Lauderdale for a meet four days before nationals.

Two alternatives have been mentioned. One would be to move our meet to March, which would not be desirable and may conflict with local meets. Betsy Durrant has suggested we consider May. In a recent email, Stu Marvin, meet director, explained the difficulties with having the meet in May.

He said he had chosen the April dates "because all of the support equipment for the meet would be in place following the YMCA National Championships the previous week. I refer to tents, officials dock (needed for two courses), pool set up (most of the time the pool in question is long course—blocks and all), concession tents, hospitality room, etc. In short, everything was ready to go, I just needed swimmers!" If he has to move the meet to May, he would have to reposition or install all of the equipment and that "would seriously damage the economics of the meet."

Stu will bring information on the meet to convention so we can consider whether we want to keep it in 2000 or move it to 2001. Bidders who are interested in hosting SCY Championships should come to convention prepared to bid for either year. From what Stu says, moving the meet to 2001 and having the 2000 meet in Zone would seem the most practical solution.

Zone Meeting Endorses OW Championships

Colonies Zone Meeting May 1, 1999 U of MD College Park

The meeting was called to order by Zone Rep Lynn Hazlewood at 2:30 PM. Present were Marcia Cleveland (CT), Dorothy Donnelly (CT), Pat Timmins (DV), Chris Colburn (DV), Barb Protzman (MD), Bob Kolonkowski (MR), Cathy Copeland (NJ), Jim Matysek (NI), Lynn Hazlewood (PV), Debbie Morrin (PV), Margot Pettijohn (PV), Jim Miller (VA), Nancy Miller (VA), Charlotte Boxley (VA), Terry Sue Gault (VA), Laura Walker (VA), Betsy Durrant (VA), Harry DeLong (VA), and Jeanne Crouse (VA). LMSCs absent were New England and Adirondack.

The first topic of discussion was the recently concluded zone championship. The zone rep thanked Terrapin Masters and the University of Maryland College Park for running a great meet. There were two issues discussed. It was the consensus of the meeting that slow swimmers in distance events be seeded in lane 1 and allowed to continue swimming while the next heat is run.

During the meet, the meet organizers announced a limit of 4 relays per swimmer. Since this had not been announced before the meet, the limit was rescinded. The meeting determined that any restrictions on entries must be announced on the entry form. It was also suggested that meet directors might put a limit on splashes per day rather than limiting relays. The decision as to which events to swim would then be up to the swimmers and coaches.

Zone finances were discussed next. At the beginning of the year, there was \$266.95. \$96 was spent to purchase 8 tshirts for the on-deck coaches. Five shirts were used leaving three available for future use. Current cash available as of May 1 is \$170.95. The total for convention expenses will be \$670.95 after the LMSC's pay their \$50 fee.

Harry DeLong, webmaster, gave a status report on the zone web site. The web site is currently being housed on the Virginia LMSC site at www.vaswim.org. Currently there are links to all Colonies LMSC web sites and a list of events around the zone. Soon the zone meet records will be added.

Chris Colburn of Delaware Valley LMSC organized on-deck coaching for the SCY championships just concluded. The program was run like on-deck coaching at nationals. It was moved, seconded, and approved that we continue to have on-deck coaching at Colonies Zone championships. There should be an announcement in the meet entry forms to notify the swimmers. The first few years there should be an explanation in the entry form of on-deck coaching and how to use it.

Rutgers University said they may be able to host the 1999 SCM Zone Championships, possibly November 13–14. It was moved, seconded, and approved to have the 1999 SCM Zones at Rutgers if possible.

A request was made for a volunteer to take over the job of zone records keeper from George McVey.

A discussion of Swim Magazine listings was held. The Zone Rep explained how to get events listed and what kind of lead time is required. A schedule for the next three issues was distributed so meet directors can submit their meet listings on time.

Resolution on Open Water Champs

At the Zone Meeting last May, members present voted to implement a series of open water swims to begin in summer 2000.

Colonies Zone shall conduct Open Water Zone Championships each year as follows:

- 1) There shall be a series of three (3) Open Water Zone Championships awarded.
- 2) For the purposes of awarding championships, the Zone will be divided into three (3) areas. Each area shall host one (1) championship per year. The areas shall be made up as follows: a) Area 1—New England, Connecticut, Niagara, and Adirondack; b) Area 2—Metropolitan, Delaware Valley, and New Jersey; and c) Area 3—Maryland, Potomac Valley, and Virginia.
- 3) Distances for the swims will be at the discretion of the meet host, but shall be a minimum of 1 mile.
- 4) The Zone will design and produce championship medals or alternative awards to be used by the meet hosts.
- 5) At the end of the series, zone champions for each age group will be named. Placing will be determined by accumulated points earned in individual championships. To be eligible for zone champion, a swimmer must have participated in and completed a minimum of two (2) zone championships.
- 6) A to-be-named committee will search for a sponsor for the championship series.
- 7) Only USMS sanctioned events shall be eligible for Zone Championship status.
- 8) Bids shall be awarded at the annual meeting held approximately 2 years prior to the championship being awarded. Any championship slots not filled may be awarded by the Zone Rep during the year or at the convention meeting the next year.

DCAC Wins Fourth Consecutive IGLA Championship

The District of Columbia Aquatics Club competed in the Tenth International Gay and Lesbian Aquatics Championships in Atlanta, Georgia, held June 18 to 20.

The competition took place at the Georgia Tech Aquatics Center, site of the 1996 Olympic Games. 716 swimmers competed and there were 31 teams from 8 countries. DCAC brought 102 swimmers, three swimmers more than the host team, Atlanta's Rainbow Trout.

When the last race was over, DCAC had scored 2598.5 points, while second place Atlanta had scored 1088.5. The victory secured DCAC a place in the record books: an unprecedented fourth consecutive IGLA championship.

DCAC swimmers broke one world and five U.S. National masters records. There were three DCAC swimmers who won eight out of a possible eight gold medals (five individual and three relay). There were many meet records broken and most importantly, a great number of individual basts.

DCAC would like to congratulate the Atlanta Rainbow Trout organization for running an amazing meet. Finally, we would like to thank our incredible coach, Jerry Frentsos, for his guidance and inspiration over the last year. On to Paris for IGLA 2000!

Finance Group to Consider Funding Needs

Possible sources of revenue are: 1) Sponsors and fundraising activities; 2) Charge \$1.00 per swimmer entered in zone championships; and 3) Charge 25¢ per swimmer registered in the zone.

Seeking sponsors and running fundraisers is an insecure method of raising money. In addition, we would need a committee in place made up of people who know how to do this effectively and are willing to volunteer.

A conservative estimate of entries per zone championship would be 400 for SCY, 300 for SCM, and 350 for open water. This would raise approximately \$1050. However, we are having difficulty setting up a SCM championship each year and there is a wide variety of entries in open water swims. We can count on this method for raising some funds each year, but we wouldn't know from year to year, how much that would be.

In 1998 we had 7,112 swimmers registered in Colonies Zone. At 25¢ per registered swimmer, this would give us income of \$1,778. This is the most secure method of raising money, since we will have a pretty good idea of how much we will have each year. In addition, our smallest LMSC, Adirondack with 223 registered in 1998,

would pay \$55.75, only \$5.75 over what they now pay. At the high end is Potomac Valley, which would owe \$384 based on a registration of 1,536. Before we discuss this in the meeting, each LMSC needs to determine how they would feel about this method of raising money, since it will impact their own finances.

Championships Work Group

The main job of the championships work group is to discuss championship awards for the open water championships. The work group needs to determine what kinds of awards to purchase, which vendor to use, how to produce a design, and the quantities needed.

We need to determine if we want to proceed with providing awards for the individual championships. The purpose of this part of the resolution was so the awards would indicate that the race was a zone championship. Because so few awards are given out at open water swims, a meet host could not benefit from economy of scale when purchasing awards (as pool meets can).

In addition, there is the subject of the awards for overall champions in each age group to consider. These awards will be totally funded by the zone whereas the awards for each championship will ultimately be purchased by meet hosts allowing us to recoup that investment.

Help for Small LMSCs

One of the topics that will be discussed at the Zone Committee meeting at convention will deal with encouraging small LMSCs to attend convention. A small LMSC is defined as one with less than 250 swimmers. Even though Adirondack fits that profile, they usually have at least one convention delegate.

There are 18 LMSCs with less than 250 swimmers and seven of them have 100 or fewer. Not only do they have difficulty financing convention delegates, but they have problems recruiting volunteers and are generally not represented at convention. One zone in particular, Breadbasket, has seven of the small LMSCs including four with 100 or fewer swimmers. Breadbasket always has difficulty filling committee slots.

One of the ideas is to provide financial aid for the small LMSCs so they can have representation at convention. Northwest Zone, which has five small LMSCs has taken the lead and raises funds to help their small LMSCs come to convention.

If anyone in Colonies Zone has some ideas about what can be done to help, please let me know before the Zone Committee meeting which is on Friday at 9:00 AM.

Publications Work Group

The zone web site is up on the internet, but still needs to be more fully defined and expanded. Harry DeLong will be leading this discussion. Some of the included the topics will be: 1) Where to house the zone web site; 2) design of the pages; 3) contents of the web site; 4) access to the site for updating purposes; 5) web site contributors; and 6) cost to the zone.

The topic of where the web site will be housed is important for the finance committee discussions. We must determine if we are going to be part of Virginia's site or have our own site. With our own site, we could allow multiple contributors to add pages much as we can do on the USMS site. In addition to the colonies zone site located in Virginia Masters site, zone information is on my personal site, Garden State Masters site, and a member of Terrapin Masters personal site. Each time a team runs a championship, the entry form and

results are put on their own sites.

While I appreciate the generosity of people and organizations who provide web space for the zone, this is becoming a confusing mess that will only get worse as time goes on. I believe that anything that pertains to the zone, such as zone championships results, zone meet records, zone newsletters, etc., should be housed on an integrated site. This will allow us to maintain the zone archives in a central location and make sure information doesn't get deleted unless we want to do so.

Colonies Zone Operating Guidelines

The CZOG listed below is a compilation of decisions that have been made in zone meetings in past years. It also recognizes defacto decisions that are implied by general practice. Any zone member who disagrees or wants to change any of the guidelines, please let me know.

Section 1: Administration

- 1.1 Any swimmer registered in Colonies Zone shall be eligible to vote on zone business at all times.
- 1.2 Issues unresolved during zone meetings will be completed by email, phone, snail-mail, etc.
- 1.3 Zone Policies
 - 1.3.1 A list of zone policies shall be developed and maintained by the Zone Rep.
 - 1.3.2 These policies shall include, but not be limited to, decisions made in zone meetings and generally accepted practice over the years.

Section 2: Championships

- 2.1. The zone shall sponsor five (5) championships each year: 1) SCY in the spring; 2) SCM in the fall; and 3) a series of three (3) open water championships.
- 2.2 Bids shall be awarded at the annual meeting held approximately two (2) years prior to the championship being awarded. Any championship slots not filled may be awarded by the Zone Rep during the year or at the convention meeting the next year. Bid forms shall be distributed through the zone newsletter and on the zone web site.
- 2.3 Only USMS sanctioned events shall be eligible for zone championship status.
- 2.4 Pool Meets
 - 2.4.1 The SCY meet in the spring should not conflict with USMS Nationals, Y Nationals, or religious holidays. It should be no more than 3–4 weeks before USMS Nationals.
 - 2.4.2 It would be preferable to emphasize the SCM meet in the fall as it will not conflict with SCY Nationals.
 - 2.4.3 Zone meets will be 2–3 day meets and should include all individual events and, if possible, all relay events.
 - 2.4.4 Slow swimmers in distance events should be seeded in Lane 1 and allowed to complete their swim (under hand timing) while the following heats proceed.
 - 2.4.5 Any restrictions on entries shall be posted on the entry form. Meet directors should consider limiting entrants to a specific number of splashes per day rather than specifying limits on relay entries.
 - 2.4.6 The zone will sponsor on-deck coaching at zone championships. There should be an announcement on the entry form to notify swimmers. The first few years, on-deck coaching concepts will be explained. USMS On-Deck Coaching t-shirts will be purchased for the coaches to wear for identification.
 - 2.4.7 Zone meet records shall be maintained for SCY and SCM championships and shall be part of the scoring for the championship.
- 2.5 Open Water Championships
 - 2.5.1 For the purposes of awarding championships, the Zone will be divided into three (3) areas. Each area shall host one (1) championship per year. The areas shall be made up as follows: 1) Area 1—New England, Connecticut, Niagara, and Adirondack; 2) Area 2—Metropolitan, Delaware Valley, and New Jersey; and 3) Area 3—Maryland, Potomac Valley, and Virginia.
 - 2.5.2 Distances for the swims will be at the discretion of the meet host, but shall be a minimum of one (1) mile.

- 2.5.3 The Zone will design and produce championship medals or alternative awards to be used by the meet hosts.
- 2.5.4 At the end of the series, zone champions for each age group will be named. Placing will be determined by accumulated points earned in individual championships. To be eligible for zone champion, a swimmer must have participated in and completed a minimum of two (2) zone championships.
- 2.5.5 A to-be-named committee will search for a sponsor for the championship series.

Section 3: Publications

- 3.1 Newsletter—The Zone Rep shall publish a newsletter several times per year and use it as a method of communicating with leaders of the zone. The newsletter may be distributed by email and posted on the web site. Leaders without email, or those who so desire, shall have their copy printed and mailed.
- 3.2 Web Site—A zone web site will be developed and be ready before the 1999 convention.
- 3.3 Big Meet Guide—The Big Meet Guide will be updated and distributed to all LMSC's in the zone.
- 3.4 Swim Magazine Listings—The Zone Rep shall collect 2–3 event listings to be published under Colonies Zone in Swim magazine. The criteria for selection shall be published in the zone newsletter and on the web site. In addition, the Zone Rep will notify all LMSC's by email when it is time to submit listings.

Section 4: Finance

- 4.1 Each LMSC shall contribute \$50 to fund convention expenses for the Zone Rep.
- 4.2 Financing strategies shall be developed to fund other zone projects.
- 4.3 Any zone fund raising shall not conflict with or interfere with LMSC fund raising efforts.

Section 5: Awards and Recognitions

5.1 If zone awards are developed, they should recognize all workers, not just the zone leaders.

Section 6: Archives

- 6.1 The Zone Rep shall be responsible for maintaining archives of the zone history.
- 6.2 Archives may be on hard copy or electronic.
- 6.3 Archives may be physically maintained by the Zone Rep or by delegated zone officials.
- Archives should include but not be limited to: 1) Meeting minutes; 2) newsletters; 3) zone championship results: 4) zone meet records; 5) LMSC bylaws; and 6) newspaper articles.
